THE CONSTITUTION

Since the Articles of Incorporation were drawn up and adopted a number of changes have been enacted by the members assembled at various triennial meetings. These articles are the Constitution of the Association. For the benefit of the membership, the Constitution, as revised up to and including the Ninth Triennial Meeting held in Minneapolis, Minnesota, April 5, 1951, is printed in this issue of the News Letter.

ARTICLES OF INCORPORATION OF THE NORWEGIAN - AMERICAN HISTORICAL ASSOCIATION AS REVISED BY DECISIONS
AT THE VARIOUS TRIENNIAL MEETINGS

The name of the corporation shall be the NORWEGIAN-AMERICAN HISTORICAL ASSOCIATION.

Its general purpose shall be to seek and gather information about the people in the United States of Norwegian birth and

descent and to preserve the same in appropriate forms as his-

III.

Its general plan of operation shall be to obtain by gift and from membership contributions the funds required for:

1. Helping to maintain and develop Norwegian-American historical archives at such places or institutions as in the judgment of the executive board shall be found to be advantageous and desirable; (at the first regular triennial meeting, 1927, a resolution was passed establishing the Archives at St. Olaf College):

College);

2. Helping to maintain and develop the Norwegian-American museum at Decorah, Iowa, known as the "Norwegian-American Historical Museum";

3. Encouraging and promoting Norwegian-American historical research and literary work;

4. Publishing monographs and other works dealing with Norwegian-American history, literature, art, and culture; and

5. Publishing a periodical devoted to Norwegian-American history, literature and culture.

The location and principal place at which the Association shall transact its affairs shall be the city of Minneapolis, in the state of Minnesota.

The Association shall have three classes of members: associate members, sustaining members, and life members: Each member, regardless of class, shall have one vote at all general and special meetings of the Association. Any person over eighteen years of age may become a member upon written application to the financial secretary stating name, address, and occupation, and paying to the secretary an admission fee, which is to be five dollars for associate members, ten dollars for sustaining members, and one hundred dollars for life members. The associate members shall pay an annual dues of five dollars and the sustaining members an annual dues of ten dollars after the year in which the admission fee is paid. Life members shall be subject to no dues or charges except the admission fee. be subject to no dues or charges except the admission fee.

VI.

The officers of the Association shall be a president, a first vice president, a second vice president, a secretary, and a treasurer, who shall be elected at a meeting of the members, which is to be held every third year at said city of Minneapolis on the first Saturday in May, unless that Saturday falls on the first day of the month, then the meeting is to be held on the second Saturday of May. Said officers shall be so elected and hold office for a term of three years. At the time and place of their election, said officers shall appoint four members of the Association to serve with them for a period of three years, who together with said officers, shall constitute and be designated the Executive Board of the Association and have the general management of its affairs. At the close of the triennial meeting of the members and at the place of such meeting, the Executive Board shall appoint, for a term of three years, a Board of Finance, which is to consist of five or more members of the Association, of which Board the Treasurer of the Association shall be a member ex officio. Of the members of this Board of Finance, one shall be designated assistant treasurer and he shall function in the place of the treasurer elected by the members when for any reason the latter is unable to act. It shall be the duty of the Board of Finance to devise ways and means for obtaining funds needed by the Association. The Executive Board, at the time and place of the election and appointment of the members thereof, shall also appoint for a term of three years a Board of Editors from among the members of the Association, to consist of three or more persons, one of whom is to be designated and is to act as Managing Editor. This Board shall edit and publish all the publications of the Association which previously have been authorized by the Executive Board. At the close of the triennial meeting of the members and at the place of such meeting, the Executive Board shall appoint for a term of three years a Board of Archives from among th on the Board of Archives.

NOTES FROM THE SECRETARY'S DESK

TOTAL FUNDS ACCOUNTED FOR \$ 9,703.71

The following letter from Attorney Frederick W. Nelson of Racine, Wisconsin, seemed so interesting to us that we immediately wrote Mr. Nelson and asked his

permission to share the letter with our members:
"I just finished reading your latest book on Old Muskego concerning the translation of Søren Bache's diary. Toward the end of the book Bache mentions something about his duties as administrator of the estate of his late friend, Johannes Johansen.

"Today when I was at the court house I checked the files for this estate and sure enough there it is in Box 9, File 161. The proceedings were started about in May or April, 1846. Everything is written in long hand. Years ago the court house in Racine burned and most of the records were destroyed, but these records show they went thru the fire. Besides being old the records are also charred, all of which makes it all very interesting.

Bache must have had quite a job. The inventory is complete right down to the last pants button, and I mean that literally. Everything was sold and each item listed as sold even down to the last and individual cent. The undertaker was paid \$8.50, the doctor in the last illness received \$15.00, and Bache got \$15.00 or \$20.00 as administrator, about \$1.00 a day. There is no lawyer in the case, the judge in those days did all the work. The administrator was also paid an extra \$8.00 for translating."

More and more people are remembering the Archives of the Association. Our newspaper collection has been augmented to a marked degree during the past two years.

The Waldemar Ager family in Eau Claire, Wisconsin, has presented a complete set of "REFORM," the paper edited by the late Waldemar Ager. All volumes of the set are bound. Except for three volumes, we now have complete, "AMERIKA," edited by Rasmus B. Anderson. We have not had the time nor the funds necessary to sort and arrange the stock we have of "SKANDINAVEN," and likewise of "DECORAH POSTEN." Apparently we have almost complete sets of these two publications. "NORDISK TIDENDE" has promised to provide the missing numbers as soon as we have taken inventory of what we already have.
