Triennial Meeting

"A triennial meeting of the members shall be held every third year." So state the NAHA By-laws. The nineteenth such meeting will be held on Saturday, September 26, 1981, in the College Center at Augsburg College, Minneapolis. President Roy Thorshov will call the meeting to order at 4 p.m.

The meeting will consist of reports from the officers and deal with other matters of business prescribed by the Charter. The terms for all members of the Executive Board expire at this time and a new board must be elected. Members who live far away from Minneapolis and who cannot attend are invited to forward their proxy (see page 3) to the Secretary. Those living in or near Minneapolis are urged to attend. Over and above the agenda of the business meeting, which can use broad representation and many voices, is the fellowship and the revival of interest that takes place when good folks get together in support of common objectives. The officers of the NAHA in particular both need and enjoy contact with the members who sustain the Association.

THE BANQUET

As has been true in the past, a banquet will follow the afternoon business meeting, preceded by a social hour (6:30-7:00). The dinner, scheduled for 7:00 p.m. in the College Center, will feature Dr. Rochelle Wright from the University of Illinois at Urbana. "Shelley," as she is known to her friends, will lecture on immigrant ballads. She provides a remarkable blend of analysis and entertainment. In addition to her scholarly insight into this interesting subject, she plays the guitar and has a fine singing voice. Sidney A. Rand, former president of St. Olaf College and former Ambassador to Norway will be the M.C.

Because the social functions sponsored by the NAHA are at best infrequent, we wish to make the most of those that do take place by reaching as many members and potential members as is possible. The Chair Fund

Below are listed the contributors since the March newsletter. News in Brief

- Several books and studies that relate to our interests have been received. Arnfinn Bruflot's novel, Inn i Amerika, treats the first three years of a young immigrant's life in and around Tacoma, Washington. The author clearly relies on many of his own experiences as he depicts life in factories and in lumber camps in the late 1920s. The book is available through Det Norske Samlag, Postboks 4672, Sofienberg, Oslo 5.
- Recollections . . . My First 75 Years by Palmar J. Hertsgaard, a well-written autobiography, covers childhood, education, the depression and the later positions he held in many areas of service.
- Scando-Americana: Papers on Scandinavian Emigration to the United States, edited by Ingrid Semmingsen and Per Seyersted was published by the American Institute at the University of Oslo.
- Two additional studies on Norwegian-American writers arrived recently: Drew Rogers, "The Norwegian Immigrant Experience as Depicted in the Fiction of Simon Johnson;" and "Nicolai Severin Hassel: The First Norwegian-American Novelist," by Veslemøy Steennæs Omenaas.
- From Selma S. Casberg of Holmen, Wisconsin came Svartbek, Christiansen, Tømmerstigen, Kasberg and Casberg Family History, 1980, an impressive work of 526 pages.
- Lawrence O. Hauge, a member of the NAHA Executive Board, received recently the Norwegian St. Olaf

- Medal. The presentation was made by Knut Hedeman, the Norwegian Ambassador to the United States.
- Charlotte Jacobson, Archivist and Curator, recently completed processing the papers of Andrew E. and G. Norman Wigeland, a collection filling thirteen document boxes. Andrew Wigeland, prominent Chicago banker, served as Treasurer of the NAHA for many years, and together with his brother supported generously Norwegian-American interests.
- On the cover page of the Texas telephone directories (Southwestern Bell) is a reproduction of a painting portraying ten persons who played an important part in the state's history. One of these is Elise Waerenskjold. The NAHA published her letters and articles under the title *The Lady with the Pen* in 1961.
- The University of Oslo International Summer School offered for the first time a course, consisting of 26 lectures, on Norwegian emigration. It was taught by our editor, Odd S. Lovoll.
- The University of Oslo press hosted a seminar on Norwegian emigration, followed by a luncheon on August 11, attended by 30 persons. The purpose was to give scholars and NAHA members an opportunity to meet Dr. Lovoll. Erik Rudeng of the University press and Kjetil Flatin, Director of the International Summer School, made the arrangements.
