# The Fifteenth Triennial Meeting

#### Fund Drive Launched

The most dramatic aspect of the triennial meeting held in Chicago, June 7, was the action taken by the Scholarship and Grants-in-Aid Committee. This committee, consisting of Dr. Gunnar Gundersen (chairman), Professor Kenneth O. Bjork and Mr. Magnus Bjorndal, reported at the close of the general session that a sum of \$7,000 had been donated or pledged to this fund. An additional \$3,000 has been pledged since that date. So far all donations and pledges have come from members of the Executive Board. Additional funds will be solicited from members and friends of the Association.

The committee has set an initial goal of \$30,000, which it hopes will be increased by direct gifts and bequests. The fund will be used to assist scholars to complete manuscripts which will ultimately be published by the Association. Editor Kenneth O. Bjork explained that a number of young scholars find it difficult for economic reasons to give the time needed to produce manuscripts which are in accord with NAHA publication standards. In many instances worthwhile projects suffer delays, said Dr. Bjork, because of the pressure of teaching assignments.

This fund will appropriately be called the Theodore C. Blegen Memorial Fund, in honor of the late editor who served the Association from its inception in 1925 to 1960.

Dr. Gundersen, who spoke for the committee, expressed the hope that the generosity shown by the members of the Executive Board would provide the needed inspiration for similar generosity among members and friends of the NAHA. During the course of the year 1970, each member will be asked to contribute to the fund and also provide the committee with the names of potential donors who may otherwise escape their attention. This committee, made up of men with vision and noble plans for the future of the NAHA, deserves our wholehearted support.

# Magnus Bjorndal—President

Magnus Bjorndal, president of Tech Laboratories, Inc., in Weehawken, New Jersey, succeeded Lionel G. Thorsness as President. Attorney Thorsness of Chicago had ably served as President for nine years, the longest term thus far. Mr. Thorsness will continue to serve on the Executive Board, holding the title of Honorary Chairman. He has served the Association in an official capacity since 1945.

Mr. Bjorndal, an engineer and industrial executive by profession, has for many years taken an active interest in Norwegian-American cultural affairs, and has given generously of both his time and money to causes he found worthwhile. He has served the Association since 1948, first as a local vice president, later as a member of the Executive Board, and in recent years as Vice President.

#### Three Members Added to Executive Board

#### Banquet

The banquet held at the Chicago Norske Klub was among the Association's more successful ones. A total of 160 members and friends attended. Participating in the program were Consul General Finn Koren, Kenneth O. Bjork, and O. G. Landsverk. The Normennenes Male Chorus, under the direction of Knut Hanson, provided a number of selections. Dr. Henrietta Larson, formerly professor of history in the School of Business Administration at Harvard University, gave the main address, speaking on the topic "The Businessman in Norwegian-American History."

Mr. J. Bernard Jacobsen and Mr. Truman Eddy arranged the banquet and managed all attending details such as invitations and entertainment. The large attendance and over-all success of this banquet reflects careful planning and much hard work on the part of Mr. Eddy and Mr. Jacobsen.

#### Pioneer Cook Book

The Norwegian-American Museum has recently issued *Pioneer Cook Book*. The book, compiled by the Volunteers of the Norwegian-American Museum, is a neatly arranged and carefully edited work. A volume of 219 pages, it contains a table of contents, an index, illustrations by Thelma and Elma Olsen of Elkhorn, Wisconsin, instructions on how to make everything from soap to butter, and even some nineteenth-century hints on proper housekeeping, manners and dress. The book sells for \$2.50, and can be bought directly from the Norwegian-American Museum, Decorah, Iowa.

# THEODORE C. BLEGEN. 1891-1969

Theodore C. Blegen served the Norwegian-American Historical Association as Managing Editor during its first thirty-five years of existence. During this time, with a steady and determined hand, he guided into publication a total of forty books, two of which he authored himself. Through him the Association gained national recognition for its professional editorial standards. Because of his creative insight and deep humanity, he gave dignity and internationally recognized relevance to migration studies.

In recognition of his contribution to historical scholarship, the Scholarship and Grants-in-Aid Fund currently being raised by the Association will bear the name "The Theodore C. Blegen Memorial Fund."
