Andrew A. Rowberg's Valuable Hobby

In the NAHA archives is a little-known but much-used biographical file, a product of Andrew Rowberg's unique hobby of 50 years. Shortly after graduating from St. Olaf College in 1910, Rowberg became a member of the Mohn Printing Company, Northfield, Minnesota. There he helped edit the news section of the **United American**, a weekly newspaper devoted to the publication of news of particular interest to people of Norwegian extraction. He soon felt the need for an extensive reference file, and as a result the "Norwegian-American Biographical and Genealogical File" came into being.

O. E. Rølvaag requested that Rowberg turn his file over to the NAHA, even after doing so, Rowberg-with much help from his wife-has continued to devote an average of four hours per week to this file. Growing steadily down through the years, it now consists of over 100,000 newspaper clippings (biographical in content) mounted on 3 x 5 cards, identified as to source, and arranged in alphabetical order. Clippings too large to be mounted on cards have been pasted in scrap books which now total 52 volumes, with an index card for each entry. While the Norwegian-American press has been Rowberg's chief source, he has also combed through many English-language newspapers and magazines.

The Rowberg file, always popular with persons visiting the Archives, is specially valuable to anyone seeking information about his family. "In working on my project," said Rowberg, "it has been with the hope that some people will become interested in their own particular background and thereby perhaps be stirred to read and explore the part which their own group has contributed to the growth of the American continent." Mr. Rowberg now lives in Lincoln, Virginia.

We all join to thank Mr. and Mrs. Rowberg for providing us with a durable and well-organized file, a file which increases in value with each year.

Treasurer's Annual Report for the Year 1960

In the year 1960 the Norwegian-American Historical Association gathered strength in both its financial position and its membership effort, in preparation for the accelerated publication program which the board of editors has undertaken.

Net worth in financial assets of the Association increased over 10% to \$31,258.95 including investments in \$26,000 U. S. Government securities, and a first mortgage high grade utility bond due in 1965.

The general campaign for addition to our membership has been conducted through the secretary's office, along with the regular business of that office. Individual members of the executive board have also carried forward a successful membership effort on the basis of personal contacts and correspondence. The list of new Life members is one evidence of this.

These combined efforts are gaining momentum in 1961, and will be sustained by the program for publishing additional worthwhile books at the rate of two volumes a year, and by the individual efforts of the entire membership to bring these new books to the attention of their friends.
